### WITNESS FAMILIARISATION

Most witnesses are unfamiliar with the pressurised environment in a courtroom or tribunal and are daunted by the prospect of giving evidence and being cross-examined. This can negatively impact on their ability to give a coherent account from the witness box. Our Witness Familiarisation training seeks to overcome any disadvantages they may face as a result of a lack of knowledge of the process, so that witnesses can give their evidence confidently and effectively.

#### **DURING THE LIVE SESSION, PARTICIPANTS COVER:**

- / Giving evidence at an adversarial hearing (or inquisitorial, if relevant)

## INTENSIVE CROSS-EXAMINATION

This follow-on course is ideal for those witnesses requiring further training, focussing primarily on practising answering questions under sustained cross-examination. The witness will experience several rounds of in-depth mock cross-examination, facing a variety of questioning techniques from an experienced advocate.

The witness will receive detailed, candid and constructive feedback on their performance in the witness box after each round of cross-examination, helping to improve their communication skills and ability to structure answers. This course enables witnesses to practice and embed their giving evidence skills and build their confidence ahead of the hearing.

Written feedback, based on objective assessment criteria, will also be provided to the instructing client after the session.

## WITNESS COMMUNICATION SKILLS

The course is delivered by two trainers, an experienced advocate and a specialist communication skills trainer. The witness will also be cross-examined by the advocate and receive detailed and constructive feedback on their performance from both the advocate and the communication skills trainer.
